

## General conditions

### Rates:

Unless stated otherwise all rates are based on door/door deliveries.

Unless stated otherwise all rates include 1 loading and 1 unloading address.

Unless stated otherwise all rates exclude:

Customs formalities;  
ADR and/or IMO Surcharge;  
VAT;  
Variable fuel surcharge. Minimum 0 %.

In case of extreme increases of costs we keep the right to negotiate the rates.

In case of extreme changing exchange rates we keep the right to place a currency adjustment factor (CAF) fee on top of the freight rates.

The minimum amount will be equal to the maximum amount of the previous sliding scale

On all rates include standard loading-and unloading hours will be applicable:

Till 3 loading meter – 0,5 hour free. Till 6 loading meter – 1 hour free.

Till 9 loading meter – 1,5 hours free. Full load – 2 hours free.

Additional time: Euro 100,00 per hour or part of this.

POD's (copy or digitally) only on request in writing. Charges € 15,00 per POD.

In case of cancelling an order after 12.00 hours prior to day of loading, we reserve the right to invoice 70% dead-freight. When the cancelling is done on the day of loading 100% of the freight costs will be charged.

Unless otherwise stated, our rates are based on direct collection and delivery by international tautliner trailer, assuming that both the supplier as your company have access to a trailer and have the facilities to load/unload the goods.

Unless otherwise stated, our rates are based are not valid for pick-ups and/or collections on islands. These are on request.

Euro pallets of other kind of pallets will not be exchanged.

For packages with a length over 2,4 mtr following calculation will be applicable.

**Prohibited Goods and Sanctions Compliance:**

The Sender is not permitted to offer goods for transport that are subject to international, European, or national sanctions legislation, including—but not limited to—goods listed on sanctions lists issued by the European Union, the United Nations, the United States (OFAC), or any other competent authority. Bring Cargo NL-BE likewise does not accept goods falling under the Chemical Weapons Convention (CWC), dual-use items for which the required licence has not been obtained, or any other dangerous or regulated goods whose transport is prohibited under applicable laws and regulations.

The Sender declares and warrants that the goods offered for transport are not subject to any such prohibitions or restrictions, and that all required licences, certifications, and documentation are complete and accurate. The Sender shall indemnify and hold harmless Bring Cargo against any damage, costs, penalties, or other consequences arising from any breach of this obligation.

Bring Cargo NL-BE reserves the right to refuse, suspend, or terminate shipments if it suspects that the goods fall under the aforementioned prohibitions or restrictions, or if insufficient documentation is provided.

**Various:**

Transport insurance will only be covered by written instructions.

Acceptance order after determined solvency by our insurance company. In case of a negative advice we will ask for a payment in advance.

We do not transport personal effects and do not make deliveries and/or collections at private persons.
